2013 GIVING REPORT



We're speechless. Our donors and the giving community made 2013 an outstanding year for the Omaha Community Foundation!

Our family of over 1,200 donors made 8,300 grants to more than 1,800 nonprofits. That translated to \$132 million being infused in nonprofits – a record year for the Foundation. Not only did donors give, but they also invested in future giving by adding a record \$297 million to OCF accounts. That's a 45 percent increase over our previous best year in 1999. And, our assets are now over \$937 million which is double the pre-recession asset level in 2007. Wow! That is tremendous growth for the Foundation, but more importantly for our community.

This was also our inaugural year for Omaha Gives!, a 24-hour online fundraising event for local nonprofits. We didn't know what to expect, but the momentum and positive energy around the event was overwhelming. It was the most fun day of work we've ever had. On May 22, 2013, 11,000 people gave over \$3 million to 308 nonprofits. Witnessing the power of what can happen when the community comes together around giving is what makes our collective hearts beat.

This kind of philanthropic investment is what makes our community great. We can't wait to see all the good that grows from giving!

The Omaha Community Foundation is made up of a community of over 1,200 donors who have collectively given over \$1 billion to more than 3,000 charitable organizations since our inception in 1982. Our family of donors has given over \$1.5 billion in gifts to the Foundation. We serve 9 county community foundations in Southwest Iowa that are affiliated with the Foundation. In addition, 18 supporting organizations work with the Foundation.

OMAHA GIVES! 2013

On Wednesday, May 22, 2013, we held our first giving day, Omaha Gives! – 24 hours of incredible generosity, excitement and support for our nonprofit community! When all was said and done, over 11,000 individuals raised \$3.07 million for more than 300 area nonprofit organizations! Included in the total was \$565,000 in matching and prize funds and over \$1 million from our family of donors!

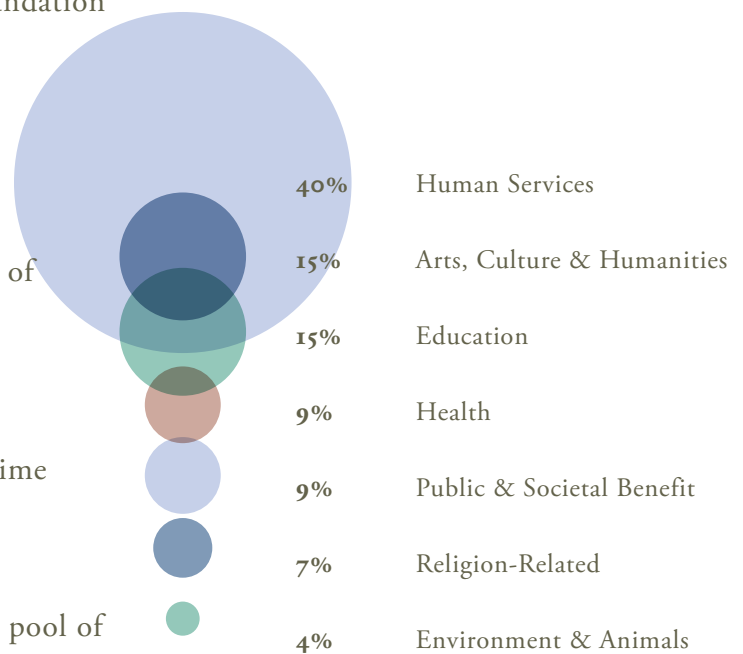
WHY HOST A GIVING DAY?

- Raise awareness of nonprofits and philanthropy throughout our community
- Engage younger and new donors
- Raise awareness about the Omaha Community Foundation to a new audience
- Build the capacity of nonprofits, including helping nonprofit organizations tell their story and increase online giving capacities

RESULTS:

- Amount raised: \$3,075,533.57 (includes \$565,000 of matching and prize funds)
- Nonprofit participants: 318
- Individual donors: 11,006
- Number of donations: 19,038
- 30% of donations (5,581) were self-reported first-time donations to an organization
- 100% of nonprofits received a donation
- OCF donors contributed over \$1.14 million
- Donations were increased by 25% as a result of the pool of matching funds (ie, nonprofit organizations received \$12.50 for every \$10 donation)
- 69% of donations were \$25 or less; 94% of donations were \$100 or less
