In 2012, over \$125 million was granted to nonprofits on behalf of donors – an 85 percent increase from 2011 and the best year ever in our history. Gifts also increased by 88 percent from 2011 - \$116 million in gifts was received by the Foundation. This kind of giving is exceptional. And we can't thank our donors enough.

The Omaha Community Foundation is made up of **a community of over 1200 donors** who have collectively given over \$906 million to more than 3000 charitable organizations since our inception in 1982. For ten years, we have been nationally recognized in the Philanthropy 400.
