

## **COVID-19 Response Fund**

The pandemic magnified existing inequities in our community—the same inequities we've identified through our work on The Landscape. This background enabled us to quickly and efficiently take action to help with the economic, health, and social consequences of the outbreak. We created the COVID-19 Response Fund to provide flexible resources to organizations in the Omaha-Council Bluffs metro area working with communities that are disproportionately impacted by the coronavirus.

# Chartered Advisor in Philanthropy (CAP)®

To earn the CAP® designation, professional advisors must pass three graduate-level classes taught through 15 sessions over the course of a year. This rigorous, interdisciplinary program gives professionals real-world examples along with best-practice curriculum and lessons from local experts. The program has successfully paved an educational pathway to bring awareness to donors about the needs of the community and giving wisely.

## **Impact Investing**

With the goal of activating donors in an innovative way while infusing a new funding stream into our community, we launched the Community Loan Fund this year. Bringing a new, sustainable resource to accelerate positive societal outcomes to area nonprofits, our Impact Investing model provides both a financial return to investors, and a social return for the community.

# **Community Initiatives**

Recognizing the importance of community initiatives that scale existing work, research critical and timely issues, educate on crucial topics, or fundraise for promising projects, the Omaha Community Foundation leads the way in moving our community forward. Building from the data available through The Landscape, we're able to strategically support and advocate for our region's most critical areas of concern. This year, we published our second Community Listening Report, created the COVID-19 Response Fund, and partnered with Douglas County to distribute \$20 million through the CARES Act Fund.
