Overview of Food Services Stimulus

The Omaha Community Foundation and the Nebraska Enterprise Fund, in partnership with Douglas County, are offering **\$2 million** to support small, locally owned and operated businesses in the food and beverage industry severely impacted by the pandemic.

End of March Awardees Notified

Funds will be distributed after the grant is accepted and a grant agreement is executed between the Nebraska Enterprise Fund and the awarded business. Businesses will also be required to provide bank information for e-payment before funds are released.

Grant Disbursement: Due to overwhelming need, awards may fund all or a portion of the requested need.

Eligibility Requirements



Must be a small, locallyowned business in the food and beverage industry, based in Douglas County.



Operate under one of the following NAICS Codes:

7223- Special Food Services (i.e. caterers and food trucks)

7224- Drinking Places

7225- Restaurants & Other Eating Places



Be active through the Nebraska Secretary of State and currently collecting and remitting sales tax.

Eligibility Requirements





Have been in operation inDouglas County since January2019 and currently be open tothe public.

Have an annual gross revenue of \$1.25 million or less as demonstrated in 2019 financial statements.



Have lost at least **50%** of income/revenue in 2020 due to COVID-19, shown by a reduction in sales tax remittance.

2019 and 2020 quarterly Nebraska sales tax remittance forms.

Federal tax filing for January 1, 2019 to December 31, 2019.



Please gather the following.

Criteria for Assessment

- Funds will be awarded to businesses on a competitive basis meeting the eligibility requirements and demonstrating the greatest amount of need. Awards are dependent upon the availability of funds and will be based on the organization's annual gross revenue.
- Businesses located in zip codes with the highest rates of COVID-19, based on the Douglas County Health Department heat map, may receive additional consideration of funding.
- Additional consideration may be given to businesses that had to shut down due to governmental measures to mitigate the spread of COVID-19.
